**CANNOT BE USED TO PURCHASE AUTOMOTIVE FUEL**

**To Vendors:**  
You must collect tax on a sale of taxable property of services unless the purchaser gives you a properly completed exemption document not later than 90 days after delivery of the property sold or service rendered. In addition you must keep the certificate for at least 3 years as explained in the instructions.

In addition, I understand that I will be liable for the tax due, plus substantial penalties and interest, for any erroneous or false use of this certificate.
